LIABILITY WAIVER and PHOTO AND VIDEO USE RELEASE FORM

PLEASE READ CAREFULLY! BY SIGNING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE.

1. LIABILITY WAIVER: Entering into a wilderness area involves numerous and sometimes unforeseen assumed and inherent risks including, but not limited to, standing dead trees or trees in various stages of decay that can fall without warning and broken unattached limbs hanging precariously in the canopy. Debris and uneven terrain present risks. Some may suffer mild to severe reactions from biting or stinging insects or from exposure to plants such as stinging nettle or poison ivy. It is possible to become lost and there is always the possibility of confrontation with wildlife such as bears.

In consideration for being granted permission to enter this wilderness property, I must agree to this Release, Waiver, and Assumption of Risk. **Note: A parent or guardian must sign for a minor accepting full parent/guardian responsibility for the minor.**

I waive any claims I or my heirs, successors, or assigns may now or in the future have against Mississippi Madawaska Land Trust (MMLT) or any of its directors, officers, contractors, staff, or volunteers, release MMLT and all its directors, officers, contractors, staff, and volunteers from all liability, and agree not to sue MMLT or any of its directors, officers, contractors, staff, or volunteers, for any personal injury, death or property damage, expenses or loss sustained by me or by any person for whom I am responsible at law as a result of or in connection with entering this wilderness property and due to any cause whatsoever, including, without limitation, negligence or breach of statutory duty.
